- Need to complete financial statement and audit from 2023/ 2024 that was never completed by prior treasurer
- Need to find financials from 2023/ proper minutes with financial numbers and record of expenses voted on?? Financial statements are legally required to be presented at AGM's for non profits in Canada. Financial statements prior to 2023 were prepared and audited by the treasurer. Bylaws state they need to be audited by 2 separate, independent board members
- Paperwork is messy, many expenses are questionable and unidentifiable . I do not feel comfortable preparing financial statements for the time period before I was involved and before my kids attended this school.

Discussion was had re: being delinquent for the previous year and looking at solutions: Voluntary Disclosure is an option if choosing to have Gov't involved. Claudia can go through receipts to create a running list of outstanding cheques. Go by monthly minutes to see if recorded in there. Jen talk with Lori Maier to help sort out what's happening for 2023 invoices and transfers. Amanda check for auditor for Rockyview School if deciding to go with voluntary disclosure.
